#### Introduction

Citizen sciences are commonly defined as science by nonscientists or a form of science enacted and developed by citizens themselves, the participation of the general public in the research design, data collection and interpretation process together with scientists.

The purpose of this paper is to present the opportunities and potential challenges of citizen science and the use of lowcost sensors as a means to complement institutional or scientific data collection.

## Why use citizen science?

- Citizens are more and more interested by environmental knowledge
- Information is not always available at a scale and resolution necessary to understand environmental changes
- Collaboration between public and professional scientists can also be educational to both sides form a knowledge transfer perspective
- roblems solving, co-diagnostics, co-monitoring and solutions, co-design and co-implementation lead to better results and outcomes
- Societies and communities feel the full impact as endusers affected by scientific discoveries

# Methodology

## Polycentric Approache

- Shared responsibilities in the monitoring and management process concerning the observed ressources
- From top down knowledge to informal, flexible, localized decision-making, largely based on local knowledge and dialogue
- Help Citizens to familiarize themselves with scientific concepts.
- Citizens can watch, observe, control, monitor and submit data about complex problems

# **Asking right questions**

- How can we involve managers and elected officials in the observation process? They have access to information that scientists do not have access to.
- How can we create and animate an observer's network?
- What are the direct societal impacts societal enhancements, territorial approaches of our scientific activity?
- How can we link societal experimentation and participatory observation?
- How can we share our data with citizens? What types of citizen data can we use?
- What are the concerns of the communities impacted ?

## Key succes factors (KPI)

- Increasing the availability of open and affordable technologies that allow the collection, geolocation and analysis of new large datasets, which take into account the perception of the receiver
- Willingness of citizens to participate in complex tasks by contributing and sharing knowledge and expertise
- Digital cooperation between new and existing users thanks to cloud computing
