1 Toxicity assessment of microplastics from Loire River in the clam *Corbicula*

fluminea exposed to environmentally relevant exposure conditions

Abstract

The diffuse pollution caused by microplastic (MPs) represents a current and global concern. While the fragmentation of plastic debris into smaller particles occurs in rivers, few MPs research on freshwater species is available compared to the marine environment. The Loire River, the longest French river, is subjected to moderate to high anthropic pressure while it represents major societal and economic issues. However, effects of environmental MPs (EMPs) on aquatic organisms have not been studied yet, and no policies can take place to monitor the plastic pollution. In this study, freshwater bivalves, Corbicula fluminea, were exposed for 21 days to environmentally relevant concentrations of a mixture of < 200 μm MPs generated from plastic litter collected directly along the Loire river banks. This mixture was composed of 40% polyethylene (PE), 40% polypropylene (PP), 10% polyethylene terephthalate (PET) and 10% polyvinylchloride (PVC) (mass percentage). Ecotoxicological effects were assessed from the individual to the molecular levels on several endpoints: condition index, filtration efficiency, enzyme activities, lipid peroxidation, energy reserves and gene expression. The ingestion of EMPs caused damages at the biochemical level. Indeed, we reported an increase in catalase activity in gills and digestive mass, a decrease in TBARs in gills, a decrease in acetylcholinesterase activity in the digestive mass, a decrease of glycogen and lipid contents in the whole organisms and a significant induction of the expression of gst, cat, mp, acp genes. The current results suggest therefore that long-term exposure to realistic doses of EMPs causes toxicity towards freshwater benthic biota. Biomarkers at the biochemical and molecular levels are complementary tools allowing to prevent an early plastic contamination for aquatic organisms.

Introduction

Since the last decade, plastic pollution has become a major environmental concern due to its increasing production, estimated at 390.7 million metric tons in 2021 (Statista Research Department, 2023). Among these plastics, many are single-used and immediately discarded, in most cases

improperly. Then, they reach the terrestrial environment and ultimately end up in aquatic environments (Oliveira et al., 2019; Ferreira et al., 2019). At the global level, it is estimated that between 70 and 80% of plastics in oceans come from land-based sources (Duis and Coors, 2016). While rivers are the main entryway for plastic litter into the marine compartment, these streams are still poorly studied (Li et al. 2018). The Loire River, the longest French river with a length of 1 006 km, presents some major societal and economic issues for the country (Managing Rivers Wisely, World Wildlife Fund (WWF)). In some cities, such as Angers, the Loire water is used as a resource of drinking water and fishing is a widespread activity in this area. Since anthropic activities of towns may affect the Loire River it seems helpful to characterise the plastic contamination around metropoles in order to implement adequate policies. Moreover, once plastics reach the aquatic compartment, they can be fragmented into smaller size polymers by photodegradation (UV radiation), weathering and physical abrasion (e.g., wind and wave action), and biotic factors (e.g., microorganisms' action). Nowadays, small plastic particles (≤ 5 mm) socalled microplastics (MPs) represent a current and a global environmental concern. Indeed, numerous scientific studies reported that MPs are increasingly being observed in all components of most aquatic ecosystems worldwide, as suspended particulates in the water column, in sediments and in wastewater (Burns and Boxall 2018; Frias et al. 2020; Habib et al., 2020; Bayo et al. 2020; Dusaucy et al. 2021; Uddin et al. 2021; Vidal et al. 2023). In addition to being found in abiotic compartments, it has been demonstrated that MPs are ingested by a wide variety of aquatic biota, at different levels of food webs, from microalgae to mammals (Ferreira et al. 2019, Wang et al. 2019; Bringer et al. 2020; Qu et al. 2020; Latchere et al. 2021; Pires et al. 2023).

Among invertebrates, bivalves are considered as good bioindicators to assess plastic pollution levels (Boening, 1999). They are often used in laboratory to study the ecotoxicological effects of xenobiotics. Indeed, bivalves are filter-feeders and have the ability to bioaccumulate pollutants from their surrounding environment. Since years, Asian clam (*Corbicula fluminea*) is considered as a relevant bioindicator to assess the anthropic pollution in aquatic compartments, and recently for plastic pollution (Su et al. 2018). The presence of MPs is global in the aquatic compartments, especially in the marine environment, on which many studies have focused. Despite a major research effort conducted to study the effects of MPs on freshwater streams in general and on freshwater bivalves in particular, literature on MPs contamination of freshwater bivalves remains still sparse compared to the publication on marine bivalves. Indeed, Sendra et al. (2021) reported 56 studies dealing with marine bivalves *versus* 13 studies dealing with freshwater bivalves, of which 6 of them used *Corbicula fluminea* as their model species, the rest (*Unio pictorum, Perna canaliculus, Dreissena burgensis, Elliptio complanate* and *Dreissena polymorpha*) counted for either 1 or 2 works. In bivalves, it has been demonstrated that MPs can be retained in the gut over timescales beyond those expected for other ingested matter (Browne et al. 2008), and that MPs can be ingested by bivalves under environmental conditions (Ward et al.

2019). Once MPs are ingested, they may be retained in the digestive tract, egested through defecation, or translocated from the gut to the circulatory system (Browne et al. 2008). In addition, diverse chemicals named 'additives' are integrated to plastic polymers during their manufacture to improve their properties and extend their lifespan (Hahladakis et al. 2018). Studies focused more and more on the effects of these additives on aquatic organisms (Ateia et al. 2020; Hermabessiere et al. 2017). The few studies addressing this topic reported worrying effects on bivalves, but toxicological studies using EMPs (involving additives and aging of plastics) are still scarce. There is therefore a lack of knowledge about their effects on aquatic organisms. This was demonstrated in the review of Latchere et al. (2021) who reported that scientists often used unrealistically high concentrations of MPs in laboratory exposures. This may lead to misleading conclusions about the impacts of plastic particles on aquatic ecosystems. Also, it appears necessary to test MPs coming from macro-sized plastics collected in the environment to be as closed as possible to the environmental conditions. In this context, this study aims to evaluate the toxicity of environmental MPs (EMPs) on the freshwater bivalve Corbicula fluminea under environmental realistic conditions such as a long-time exposure (21 days), environmental exposure concentrations and use of plastics coming directly from the field. Ecotoxicological effects of EMPs on clams were assessed at different biological organisation levels, from molecular to individual levels on both relevant tissues (gill and digestive gland) or on the whole organism. We wondered in this study if the ecotoxicological effects are dependent on the exposure concentrations and/or the tested tissues. Also, we wondered if there is a link between effects at the different biological organisation levels. Results will help establishing first insights about the links between molecular effects and individual ones in an Adverse Outcome Pathway concept.

Materials and methods

Collection, preparation and characterization of EMPs

Plastic wastes were collected by hand along the Loire River banks in March 2022, near Angers, a medium city in West of France (47°42′38.34″N, -0°60′30.10″W). There is an accumulation of plastic specially at this site due to the river currents. In the laboratory, plastic wastes have been dried at room temperature for few days and cleaned with demineralised water to take off duff, sand and other dirt to avoid this matter to be transformed into microparticles. Plastic litter (bottles, rope, food packaging, diverse coloured pieces) was pre-cut and analyzed by Attenuated Total Reflection Fourier Transform Infrared spectrometer (ATR-FTIR Vertex70v, Bruker) equipped with a diamond crystal ATR accessory and a denudated triglycine sulfate (DTGS) detector. A few grams of each plastic: polyethylene (PE), polypropylene (PP), polyethylene terephthalate (PET) and polyvinylchloride (PVC) were put into a sample container with a magnetic bar, and both sides of the container were closed with two stainless steel caps. The container was inserted into a cryogenic mechanical miller (SPEX, 6770 Freezer-mill) filled

with liquid nitrogen. During the milling process, an oscillating magnetic field was generated, which drove the magnetic bar forward and backward inside the container and make the impacts with the caps. Milling consisted in 2 min of pre-cooling followed by 2 cycles of milling. Each cycle lasted 4 min with a 1-min pause between the 2 cycles. The obtained powders of plastic particles were then sieved during 60 min on a stain sieve of 200 μ m, to select particles size reflecting that of food particles ingested in the natural environment by Asian clams (Parra et al. 2021; Li et al. 2019). Fractions of PE, PP, PET and PVC under 200 μ m were then stored in a glass bottle at ambient temperature in the dark until preparation of the stock solution.

Based on the composition of polymers found in French Atlantic coastal sediments by Phuong et al. (2018), the following mixture of plastic particles has been realized (mass percentage): 40% PE, 40% PP, 10% PET and 10% PVC. This is also consistent with a recent study (Wu et al. 2022), which reported that the mostly common polymers analyzed in Asian clams sampled in the field (China) were PE (40%), PET (23%) and PP (18%). A first stock suspension at 1 mg.mL⁻¹ was prepared in milliQ water at pH 7 and sonicated for 3 minutes. Then, solutions at 0.1 mg.mL⁻¹ and 80 μg.L⁻¹ were obtained by successive dilutions of the stock suspension in milliQ water at pH 7. After sonication (3 minutes), a specific volume of the stock suspension (1 mg.mL⁻¹) or the working solutions (0.1 mg.mL⁻¹ and 80 μg.L⁻¹) was distributed every 3 days after a complete water renewal in the aquariums to obtain the following final concentrations: 0.008, 10, 100 and 500 µg.L⁻¹. These concentrations were based on Revel et al. (2019): a low concentration of $0.008 \,\mu g \, L^{-1}$ for the coast regions, a medium concentration of 10 $\mu g \, L^{-1}$ for coastal region/gyres, a higher concentration of 100 $\mu g \ L^{-1}$ for gyres, and the highest concentration of 500 $\mu g . L^{-1}$ $^{
m 1}$ for freshwater streams. In addition, a Dynamic Light Scattering (DLS) analysis was performed on the stock solution and the working solutions (Zetasizer Nano-ZS90) to detect the presence of particles smaller than 1 µm. It allowed to measure the hydrodynamic diameter and the aggregation state of particles in solution. In parallel, a spectroscopic MPs quantification by μ-FTIR imaging (micro-Fourier Transform InfraRed; Thermo Nicolet iZ10) was performed on the stock solution to characterize the number, the size and the composition of particles in the used plastic mixture. A pixel with a resolution of 25 x 25 μm was selected. μ-FTIR imaging was performed for the entire sample i.e., the entire filtration zone of the sample. Acquisition parameters were described in a recent study (Treilles et al. 2021). The with siMPle software $(v.1.1.\beta)$ μ-FTIR treated MP Library extended grouped 1 5.txt. The default matching weight of 0.5 for the first derivative of the spectra and 0.5 for the second derivative of the spectra was used, and the AAU pipeline was chosen for data processing. The minimal particle size provided by siMPle is 25 μm. The major dimension of plastic fragments provided in the output of the siMPle software were considered.

C. fluminea sampling and laboratory experimental set up

C. fluminea were collected in May 2022 in the Maine Lake located in Angers (France) (47°27'47.9"N 0°35'21.0"W). Organisms were transported to the laboratory in containers filled with sediment and water from the sampling site. They were then immediately transferred into aquaria (54 L) containing lake water (0.45 L per individual), in a temperature-controlled room at 13°C, with a photoperiod maintained at 12:12. A total of 265 clams (mean length = 25.4 ± 0.83 cm and mean weight $= 8.09 \pm 0.66$ g) were divided among five glass aquaria equipped with bubblers and covered with a glass plate to avoid plastic contamination by air. During the 10-days acclimation period, the water was replaced by tap water to progressively decrease the volume of the lake water: 100/0, 75/25, 50/50, 25/75 until 0/100. At the end of the acclimation period, 15 individuals were sampled to provide biometrical data (mass and length). Organisms were then exposed to MP for 21 days via water spiked by the four concentrations mentioned above (0.008 μg.L⁻¹, 10 μg.L⁻¹, 100 μg.L⁻¹ and 500 μg.L⁻¹). A control tank without added plastic was also put in place (Control). During both acclimation and exposure steps, the organisms were fed every 3 days with a suspension of unicellular algae Scenedesmus subspicatus, provided by Greensea. Before each feeding, algal concentration was counted on a Malassez cell to obtain 70,000 cells per individual per liter of water. Individuals were fed one hour before each water renewal. At the end of the exposure period, individuals were sampled in each aquarium: n=3 for filtration efficiency; n=10 for condition index and also used for the verification of MP ingestion; n=10 for biomarker analysis; and n=10 for energy reserves quantification. Whole soft bodies were sampled for the quantification of energy reserves and immediately frozen at -80°C, while gills and digestive glands were dissected and immediately frozen at -20°C for further biomarkers analysis.

Analysis of MPs in the organisms

A verification of the presence of MP in clams was performed to ensure their ingestion. Since the microscopy method does not allow to know the plastic composition and the μ -FTIR method does not give the colour nor the shape of MPs, it seems relevant to use both techniques for a complete characterization of MPs ingested by the organisms. Therefore, a first analysis was performed by microscopy to determine the size, the colour and the shape of MPs ingested by individuals for each condition (n=3 organisms), including the control. Thus, each clam was entirely digested in ethanol precleaned beakers containing 10% potassium hydroxide (KOH). Beakers, covered with aluminium, were placed on a heating plate at 60°C with stirring for 24 h to eliminate organic matter. The digesta was then filtered under a Büchner system using a 1.6 μ m filter (GF/A 1820-037). The complementary analysis by μ -FTIR was conducted to determine the composition and the size of MPs ingested by organisms (pool of 3 individuals). The digestion protocol was the same as the microscopy analysis and the filtration was performed on Anodisc (Whatman) membrane filters (0.2 μ m, 25 mm).

Ecophysiology measurement

Condition index

The total weight and the soft tissue weight were determined for each clam and all conditions at the beginning (T0) and at the end of the 21 days exposure period (T21). The condition index (CI) was determined as follows (AFNOR, 1985):

$$CI = \frac{\text{wet weight of soft tissues}}{\text{total wet weight}} \times 100$$

Filtration efficiency

The filtration efficiency indicates the ability of bivalves to intake microalgae and other food items from the water column and is a key function for evaluation of the individual fitness. The filtration efficiency was defined as the volume of water cleared of suspended particles per unit time, and was estimated for *C. fluminea* previously exposed for 21 days to clean water (Control) or MPs (0.008, 10, 100 and 500 µg.L⁻¹). Clams were individually placed in a 1 L beaker filled with 400 mL of water from the aquaria one hour before measurements started. Mixing was promoted by fine bubble aeration to minimize the re-suspension of faeces and individuals were placed on metal grids to let the faeces fall into the bottom of the beaker. An initial concentration of 300 000 cells.mL⁻¹ of *S. subspicatus* was added in each beaker. The filtration efficiency was then measured by an indirect method assessing the concentration of the algal solution every 15 min for 45 min according to classical algal cell counting technique (Utermöhl, 1958). Briefly, algal cells were fixed by adding a drop of Lugol Iodine solution (Iodine I₂, 5%; Potassium Iodide KI 10%) in 10 mL of sample. Cells were counted under a light microscope using a Malassez counting chamber. The filtration efficiency was expressed in cells.mL⁻¹ of *S. subspicatus*.

Biochemical analyses

Energy reserves

Protein, lipid and glycogen contents were quantified in the total homogenate using a thawed subsample for each energy storage fraction. For each condition, 10 clams were individually ground in liquid nitrogen, then the powder was homogenized with a motorized grinder in a Tris magnesium buffer (0.1 M Tris-HCl pH 8.5, 0.4 M MgSO₄, 15% polyvinylpyrrolidone (antioxidant) and 0.2% (w/v) Triton X-100 (cell membrane permeabilizer)). Lipid and protein fractions were directly stored at -80°C while the glycogen fraction was boiled during 4 minutes before storage at -80°C. Total lipids were determined by the sulfo-phospho-vanillin reaction and measured spectrophotometrically at 540nm (TECAN® Sunrise) (Frings et al. 1972). Glycogen content was estimated using enzymatic digestion by amyloglucosidase and measured spectrophotometrically (TECAN® Sunrise) at 420 nm (Carr and Neff 1984). For protein quantification, the homogenates were centrifuged at 3000 g, 10 min at 4°C. Protein concentration was

quantified using Bradford method (Bradford 1976). Lipid, glycogen and protein concentrations were expressed as mg.g-1 of wet weight (ww).

Oxidative stress, neurotoxicity and lipid peroxidation

Enzyme activities: catalase (CAT), glutathione S-transferases (GST) and acetylcholinesterase (AChE), and lipid peroxidation were quantified in the gills and digestive gland tissues of clams. Firstly, the tissues were thawed on ice and homogenized in Tris buffer at pH 7.2 (Tris 0.8 M (Trizma-base Sigma® T6791); NaCl 2 M (Sigma® S9888); DTT 100 mM (Sigma® 8349-12-3); CIP (Protease Inhibitor Cocktail, Sigma® P8340)). The homogenates were then centrifuged at 9000 g at 4°C for 30 min. The amount of total proteins was quantified using the Bradford method (Bradford, 1976). CAT activity was measured spectrophotometrically at 240 nm ($\varepsilon = 0.04 \text{ mM}^{-1}.\text{cm}^{-1}$; UviLine[®] 9600), following the dismutation of hydrogen peroxide (H₂O₂) (Claiborne, 1985). GST activity was measured spectrophotometrically at 340nm (ε = 9.6 mM⁻¹.cm⁻¹ TECAN® Sunrise) at 25°C by observing the conjugation of the 1-chloro-2,4dinitrobenzene (CDNB) and the L-glutathione reduced (GSH) (Habig et al. 1974). AChE activity was determined spectrophotometrically at 412nm (TECAN® Sunrise) at 25°C, monitoring the conversion of acetylthiocholine into thiocholine in the presence of 5,5-dithiobis (2-nitrobenzoic acid) called DTNB (Ellman et al. 1961; Galgani and Bocquene 1991). To determine lipid damage, the formation of thiobarbituric acid reactive substances (TBARs), including malondialdehyde (MDA) was measured according to the method of Sunderman et al. (1985) with a colorimetric assay (540 nm) that quantifies lipid degradation products as an index of lipid peroxidation. All specific activities were expressed either in μmoles.min⁻¹.mg protein⁻¹ (CAT) or in nmoles.min⁻¹.mg protein⁻¹ (GST, AChE and MDA).

Analysis of gene expression by quantitative PCR

Corbicula fluminea were pooled by three for each condition and were analyzed by quantitative RT-PCR for each condition. Total RNA was extracted using TRIzol reagent® (Life Technologies) from the gills and the digestive mass, according to the manufacturer's recommendations and precipitated with propan-2-ol. RNA concentration (µg.µL⁻¹) was quantified using a NanoDrop 2000 spectrophotometer (ThermoScientific®). First-strand cDNA was synthesized from 5 µg of total RNA using the Invitrogen™ SuperScript™ III kit (ThermoScientific®; T100™ Thermal Cycler, BIORAD®) according to the manufacturer's recommendations. The expression levels of seven genes involved in oxidative stress, detoxication, respiratory chain, immunity, neurotoxicity and apoptosis were analyzed using a set of forward and reverse primers by quantitative RT-PCR. The ribosomal protein 7 gene (rpl7), previously tested and compared with other genes in our laboratory, was used as housekeeping gene. Previously, the quality of each pair of primers was checked: cDNA tests were amplified by PCR (T100™ Thermal Cycler, BIORAD®. 30 cycles: 30 s à 95°C, 30 s 181 à 60°C, 30 s à 72°C), then the amplification products were separated on 1.5% agarose electrophoresis gel. After staining with ethidium bromide, the presence and size of each amplicon were verified. Quantitative PCR (qPCR) amplifications were carried

out in triplicate in 96-well microplates (CFX Connect™ Real-Time System, BIORAD®) using SYBR™ Master Mix PCR Power SYBR™ Green (Invitrogen) containing the SYBR Green dye, DNA Taq Polymerase and dNTPs. For each reaction, 1 μL of each primer (50 pmoles.μL⁻¹), 6.25 μL of SYBR Green mix, 3.75 μL of water treated with DEPC (DNase-free water) and 0.5μL of cDNA were added in each well. The qPCR reactions consisted of a first step of 10 min at 95°C (enzyme activation) followed by 45 cycles (95°C for 30 s, 60°C for 30 s and 72°C for 30 s) and 5 min at 72°C. For each primer pair, amplification specificity was verified revealing the presence of a single product on a melting curve and a no-template control assay was realised. Expression levels were estimated by evaluating the fluorescence signal emitted by SYBR-Green®. This fluorescent marker binds to double-stranded DNA (dsDNA) and the fluorescence emitted is proportional to the dsDNA present in the reaction mix. Calculations are based on cycle threshold (Ct) values. The relative gene expression ratio of each target gene was calculated following the delta-delta method normalized with reference genes (Livak and Schmittgen, 2001), which is defined as:

Quality control

To prevent a cross-contamination, all equipment used in the laboratory was previously rinsed with milliQ water and ethanol, dried at room temperature in a hood and kept under aluminum foil to avoid contact with the ambient air. During the experiments, cotton laboratory coats and nitrile gloves were worn. For both methods (microscopy and μ -FTIR analysis), during the digestion, beakers were covered with aluminum foil. After filtration, the filters were stored in closed glass Petri dishes until microscopy and μ -FTIR analysis. Due to the remaining risk of cross-contamination of the samples, blanks were performed in KOH 10%, following the same protocol. For each series of digestion, a blank sample (without organisms nor water) was performed in parallel. Blanks were also performed for the filtration step, and for the microscopy and μ -FTIR analysis. Finally, the use of plastic material was avoided at best throughout this experimental study.

Statistical analysis

Statistical analysis was carried out using XLSTAT 2019 (version 21.4.63762) and R software (version 4.0.3). Normality of data distribution and homogeneity of variance were tested using the Shapiro-Wilk and Bartlett tests, respectively. If data did not meet the conditions for parametric tests, Kruskal-Wallis test was therefore used to test for differences between the treatments. If the overall test was significant, a Dunn procedure was performed to determine which means were significantly different. If the data followed the conditions for application of parametric tests, an ANOVA was used to test for differences between the treatments. If the overall test was significant, a Tukey post hoc test was performed to determine which means were significantly different. In all cases, p values ≤ 0.05 were

considered statistically significant. Also, Principal Component Analysis (PCA) was realised using all data of biomarkers obtained for gills and digestive gland (quantitative variables) to evaluate the influence of MPs concentrations, on control and exposed *C. fluminea*, along the period of 21 days exposure. PCA was performed with the ade4 package (R software) and all missing values were removed from database to ensure the PCA realisation. Finally, overlaps were performed with qualitative variables (not used to build the PCA).

Results

Analysis of MPs in the exposure solutions and clams

The DLS analysis revealed the presence of particles under 25 µm in the stock solution and in the two working solutions (Figure S1). This is due to the non-selection of the grinded microplastics (<200 μ m). In this study, all MPs \leq 200 μ m were considered but only particles ranging between 25 and 200 μ m (analyzed by both visual and spectrometry methods) were described below. The visual observation of the stock solution (3 replicates of 100 µL) revealed the presence of 92% of fragments and 8% fibers. Among the fragments, 73% ranged from 25 to 100 µm and 27% from 100 to 200 µm, and 55% were red, 30% were black, 10% were grey and 5% were transparent. 42% of the fibers measured between 275 and 1 000 μm, and 58% between 1 000 and 1 250 μm, with 50% being grey, 39% black and 11% blue. The μ -FTIR analysis confirmed the presence of PE, PP, PVC and PET in the stock solution. Indeed, among the 851 MPs identified in 100 µL of the stock solution, PE particles counted for 71.1%, PP for 19.9%, PET for 7.9% and PVC for 0.1%. The 1.1%-part remaining was constituted of PA (0.4%) and PS (0.7%). Also, 3 particles of acrylic and 3 of polyamide (PA) were analyzed, probably due to a cross-contamination during a step of the experiment. The sizes of the MPs analyzed by μ-FTIR were identified as follows: between 31.8 and 1790.9 μm for PE; between 31.8 and 632.9 μm for PP; between 38.2 and 220.3 μm for PVC; and between 25 and 183.1 μ m for PET. The mean size \pm SD associated to this μ -FTIR analysis were: 144.8 \pm 121.7 µm for PE; 105.4 \pm 72.1 µm for PP; 80.2 \pm 34.0 µm for PET and 103.6 \pm 56.0 µm for PVC. Therefore, based on the mean values, the exposure was realised using plastic particles with a size less than 200 µm.

The verification performed to ensure that this specific size range of EMPs was ingested by the exposed clams confirmed this hypothesis (Figure S2). Indeed, both the visual count under the binocular microscope and the μ -FTIR analysis revealed an increasing presence of MPs in the clams, related to the increase in MPs concentration used in the different treatments (Figure S2). Analysis performed on the control group also revealed the presence of MPs despite subtracting the MPs found on the control filter, although fewer than those found in the contaminated conditions. MPs found on the blank filters (between 2 and 7 particles per filter) were mainly fibers (78%) measuring from 150 to 1 500 μ m, either transparent, blue, grey or pink. The two fragments were blue and pink, and measured 25 and 250 μ m

(major dimension), respectively. A light cross-contamination by acrylic and PA was also observed, probably coming from textiles worn during the experiment period, despite the precautions. Fragments and fibers with different colours (transparent, whitish/opaque, blue, grey and red) have been found in all organisms (Figure S2). PE was the dominant plastic polymer in the clams followed by PP, reflecting the MP profile of the stock solution. Neither PVC nor PET particles were found in the clams. The size of the analyzed MPs in clams measured by μ -FTIR confirmed that determined by microscopy (Figure S2) and was of the same range as the sizes of MPs determined in the stock solution.

Condition index and filtration efficiency

No mortality was recorded during the exposition period of 21 days. No significant CI difference (Figure S3) was observed between the clams sampled at the beginning of the experiment (T0, 19.30 \pm 1.52) and between the clams sampled from the control treatment and from the two lowest concentrations: 0.008 μ g.L⁻¹ (19.08 \pm 2.28) and 10 μ g.L⁻¹ (17.73 \pm 2.68) after 21 days of exposure (T21, 17.90 \pm 2.42). However, a significant decrease of the CI was observed between the clams sampled at T0 and those sampled at T21 at the highest concentrations: 100 μ g L⁻¹ (16.20 \pm 2.21) and 500 μ g L⁻¹ (16.82 \pm 3.02). In addition, after 21 days exposure, the MPs contamination had no significant impact on the filtration efficiency of *C. fluminea*, independently of MPs concentration and measurement time (Figure S4).

Energy reserves

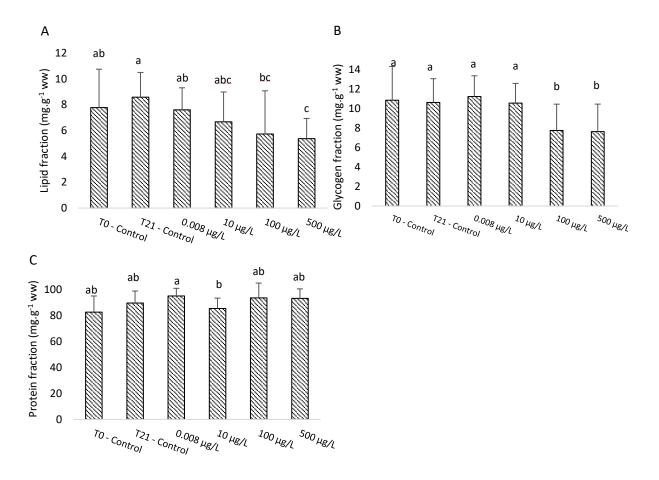


Figure 1. Energy reserve contents (mg/g wet weight \pm standard deviation) in *C. fluminea* (control and exposed to EMP). A) Lipid fraction; B) Glycogen fraction; C) Protein fraction. Different lower-case letters indicate significant differences between all groups (p < 0.05).

The exposure to EMPs during 21 days caused a decrease in glycogen and lipid contents in C. fluminea. Results indicated a significant post-exposure decrease in lipid content for individuals exposed to 500 μ g MP.L⁻¹, and in glycogen content for individuals exposed to 100 and 500 μ g MP.L⁻¹ (Figure 1, A and B). No significant change in protein contents was observed between T0 organisms and control organisms at 21 days, and the treated organisms.

Biomarkers: oxidative stress, lipid peroxidation and neurotoxicity

For all biomarkers measured after 21 days of exposure, the levels of enzymatic activities were higher in the digestive mass than in gills (Figure 2). The biomarker responses to the MP contamination differed according to the tissues (Figure 3). CAT activity was significantly increased in digestive mass of organisms exposed to 10, 100 and 500 $\mu g.L^{-1}$ compared to the control organisms, while in gills, CAT activity was increased significantly only at the highest concentration (500 $\mu g.L^{-1}$) compared to control. In both digestive mass and gills, no significant difference in GST activity was observed for the treated organisms compared to the control ones. Concerning MDA levels, significant differences were measured only in the gills. Indeed, MDA levels were significantly lower in the clams exposed to 0.008, 10 and 100 $\mu g.L^{-1}$, whereas no significant difference was measured at the highest concentration (500 $\mu g.L^{-1}$) compared to the control. On the contrary, significant differences in AChE activity were depicted only in the digestive mass. Clams exposed to 500 $\mu g.L^{-1}$ showed a significant decrease in AChE activity relative to the controls.

The first PCA (Figure S5) was based on all biochemical data: CAT, GST and AChE activities, and MDA content measured on both organs (gills and digestive mass) of *C. fluminea* exposed to the 5

treatments (Control, 0.008, 10, 100 and 500 µg.L⁻¹). This PCA showed that the studied variables related to biochemical biomarkers were organ-dependant. Therefore, we chose to represent two distinct components for a better visual interpretation knowing that PCA representations on a single axis are rarely presented. Two PCA were then performed separately, one using data obtained on gills and the other on digestive mass. These two PCA showed the relationships between biochemical biomarkers and exposure of clams to EMPs (Figure 3). Regarding the PCA performed on digestive mass (Figure 3A), the two principal components represented 73.76% of total variance, the first axe PC1 and the second axe PC2 representing 46.30% and 27.46% respectively. Exposure conditions (control, 0.008, 10, 100 and 500 μg.L⁻¹) were separated and distributed proportionally according to both axes. PC1 is mostly explained by CAT and GST variables (34.79 and 40.31 % respectively). The exposure condition at the highest concentration (500 µg.L⁻¹) was also separated from the others. Relative to PC1, a positive correlation was established between CAT and GST; likewise, a positive correlation was depicted between MDA and AChE related to PC2. In the gills (Figure 3B), the two principal components represent 59.73% of total variance, with PC1 representing 32.26% and PC2 27.46%. PC1 was mostly explained by CAT and AChE activities (35.35 and 38.25 % respectively), while PC2 was mostly explained by GST activity and MDA (50.45 and 37.48 % respectively). No evident separation between the conditions was established except for the highest concentration (500 μg.L⁻¹) separated from the control. PCA showed that exposure to the highest concentration of EMPs (500 μg.L⁻¹) was positively correlated to an increase in the activity of oxidative stress enzymes CAT and GST in the digestive mass, and only to CAT in gills. In digestive mass, exposure to high concentration of EMPs was negatively correlated to the activity of AChE (inhibition).

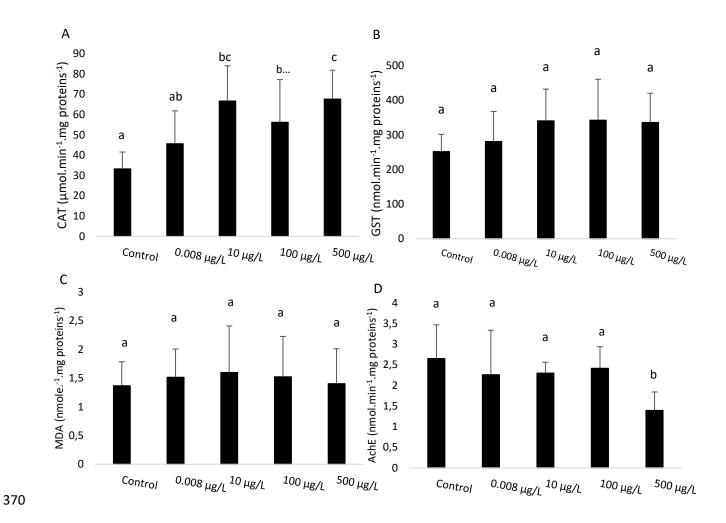

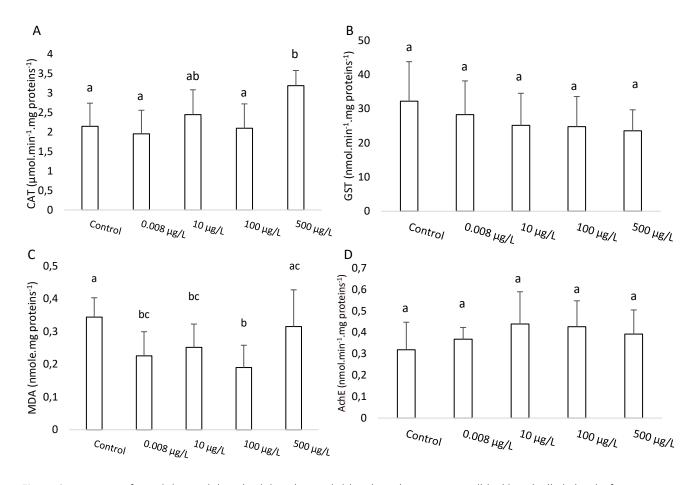
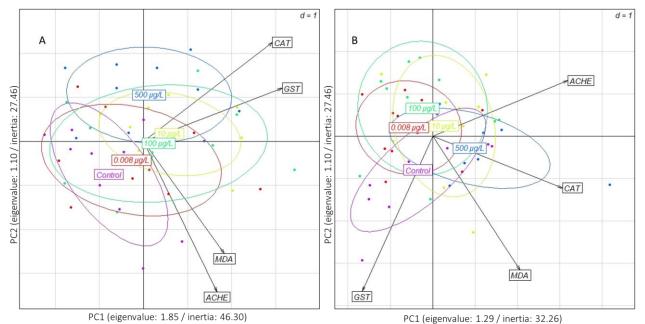


Figure 2. Activities of CAT (A), GST (B), AChE (C) and MDA (D) levels in digestive mass (black) and gills (white) of *C. fluminea* after 21 days of EMPs exposure at 0 (Control), 0.008, 10, 100 and 500 μ g MP.L⁻¹ (mean + sd, N = 10). Different lower-case letters indicate significant differences between control and MPs exposed treatments (p < 0.05).

Gene expression

As shown in Table 1, at 21 days post-exposure, analyzed genes of *C. fluminea* were only upregulated in both gills and digestive mass. These genes are involved in detoxication (gst and mt), oxidative stress (cat), respiratory chain (cox1), immunity (acp) and neurotoxicity (ache). In gills, the induction of gst, mt, cat and acp was detected only for the lowest EMPs concentration (0.008 µg.L⁻¹), except acp gene inducted also at 10 µg.L⁻¹. In the digestive mass, cat, acp and ache genes were induced only for the second lowest EMPs concentration (10 µg.L⁻¹), except cat gene inducted from 0.008 µg.L⁻¹. Therefore, significant gene inductions appeared only for the two lowest concentrations (0.008 and 10 µg.L⁻¹), while there was no significant up or downregulation of genes for C. fluminea exposed at 100 and 500 µg.L⁻¹. Overall, there was no evidence of dose-dependent effect for EMPs treatments.

Discussion

The Loire River, the longest French river, represents major societal and economic issues for the country. Indeed, this stream crosses a multitude of cities of varying sizes, some of them using the Loire as a resource for drinking water. In the region, scientist federations have even been created to inform local inhabitants and industrialists of the potential risks of the Loire pollution, and the potential sanitary

and environmental impacts. Indeed, since the anthropic activities of cities, such as Angers, may affect the Loire River, it would be helpful to characterise the plastic contamination in order to implement adequate policies. In this context, the study of the effects of MPs derived from plastic litter coming directly from the Loire banks, on the ubiquitous freshwater organism (*C. fluminea*), appeared crucial to collect data that will help to implement public policies for environmental risk management and contamination monitoring in the Loire. This is the first study reporting the toxicity of EMPs from the Loire on *C. fluminea* using a multi-biomarker approach at different levels of biological organization. This approach allowed 1) to characterize the effects of these plastics by quantifying the biological responses, aiming to link molecular to individual effects and 2) to propose tools for monitoring plastic contamination of the Loire by measuring early biological responses in order to predict potential consequences at higher levels.

Environmental realism of the experiment

One of the current questions that arise from MPs exposures conducted in laboratory is whether the conditions of experiments are realistic from an environmental point of view. In nature, MPs is an umbrella term that covers particles with various physical and chemical properties, and organisms are not exposed to uniform sizes and shapes of MPs (Rochman et al. 2017). Laboratory studies often conduct bivalve exposure at higher concentrations of MPs than the ones found in the environment. Also, they generally use MPs with a consistent shape and with a calibrated size, particles composed of only one polymer type (no plastic mixture) (Li et al. 2019; Latchere et al. 2021), and without additives, which may be responsible for the observed effects on aquatic organisms (Ateia et al. 2020; Hermabessiere et al. 2017). More precisely, one type of spherical plastic microbeads, calibrated at 1-100 μm in size, was often used for MPs exposure to clams (Li et al. 2019; Ribeiro et al. 2017; Oliveira et al. 2018; Moreschi et al. 2020; Fu et al. 2022). However, it has been demonstrated that uptake of MPs by C. fluminea varies based upon physicochemical properties, such as polymer composition and particle size (Li et al. 2019). Accounting for this, in this study, C. fluminea were exposed to a mixture of different types of EMPs (PP, PE, PVC and PET) generated from separated plastic waste collected directly from the field. Since these plastics have been more or less aged, they still contain additives integrated during their manufacture or adsorbed during their release in the environment. Lower exposure concentrations of EMPs than those used in most bivalve laboratory experiments have been selected for this study. Each grinded powder presented similar size range of MPs, but not perfectly uniform due to differences in how the polymers micronized. These size ranges fall within the range of particles ingested by C. fluminea sampled in the field (Wu et al. 2022; Su et al. 2016). Also, laboratory experiments have been conducted to confirm preferential MPs sizes ingested by Asian clams. For example, Li et al. (2019) reported that uptake of PET fibers in exposed clams was greater in the size range 100-250 μm than in other size classes $(5-100 \mu m, 100-250 \mu m, 250-500 \mu m, 500-1000 \mu m and 1000-5000 \mu m)$. In our study, size particle

ranges of MPs determined by μ -FTIR in organisms were similar for all plastic types and are also similar to the ones measured in the stock solution. The μ -FTIR analysis of the clams after the 21-days exposure revealed the presence of PE and PP but neither PVC nor PET particles were found. This is probably due to the small amount detected in the stock solution or these particles may aggregate in the solution and being less bioavailable for organisms (Revel et al. 2019).

Effects of EMPs at individual level

After confirming the ingestion of MPs by exposed organisms, biological changes at individual level were analyzed. Indeed, statistically significant alteration in the CI was observed between the clams at the beginning of the exposure (T0) and the ones after 21-days of exposure, exposed to the two highest MP concentrations. The organisms exposed to these two concentrations did not grow as much as the control clams and the ones exposed to lower MP concentrations. Naidu et al. (2022) calculated the CI of yellow clams sampled at three different locations of the northwest coast of India. The lesser CI could be due to the occurrence of a high number of < 100 μ m size MPs, as smaller size MPs can result in oxidative damage, altered feeding, depressed reproductive output in bivalves (Naidu et al. 2022). This reduced general condition may therefore be explained by disorders at lower biological levels such an allocation of energy reserves to face a stress rather than for growth, and might cause negative impacts on a long-term period. Therefore, the effects of EMPs on the whole organisms or on particular tissues (gills and digestive mass) of the bivalves were evaluated by assessing their ecotoxicological impacts using a battery of biomarkers and by comparing the expression of some genes involved in the stress responses.

Effects of EMPs at molecular and biochemical levels: relationship between gene expression and enzymatic activities

The comparison of gene expression levels between exposed and control organisms is useful for identifying the mechanisms involved in the toxicant-specific responses. These molecular markers can also provide early-detection of a stress. The biochemical markers were chosen to evaluate the possible effects related to damage caused by MPs, including the oxidative stress, lipid oxidative damage and neurotoxicity (AChE activity). Relationship between both, molecular and biochemical markers, is useful to know if gene expression induces the activity of the associated protein. The results first highlighted that an exposure to EMPs led to changes in gene expression patterns and biochemical activities at environmentally relevant concentrations, in the two tissues, with a differential response of biomarkers between gills and digestive mass (Figure 1 and Figure 2). For all biomarkers, the specific activity levels were higher in digestive mass compared to gills (Figure 1), and ecotoxicological effects were sometimes significant in gills and not in digestive mass, or inversely, reflecting the distinct physiological and metabolic pathways present in the two tissues.

Firstly, cat and gst gene expressions were quantified, both involved in the detoxication pathways: cat gene encodes catalase, an enzyme that acts as a defence mechanism against reactive oxygen species, allowing the disproportionation of hydrogen peroxide into water and dioxygen; gst gene encodes GST enzymes protecting cells against toxicants by conjugating the glutathione as substrate to xenobiotics. The induction of both cat and gst genes observed in the gills and in the digestive mass of C. fluminea is a sign of response to an oxidative stress. However, the GST activities was not significantly modified in both organs of clams in this study and the CAT activity was significantly higher only at the highest concentrations. The non-significant change of GST activity might be due to a compensatory and earlier response of the antioxidant enzyme, such as CAT or SOD (not analyzed in this study). However, some studies have reported a response of the GST in bivalves exposed to MPs. For example, Parra et al. (2021) found a significant increase of GST activity in gill, digestive gland and gonad of Asian clams exposed to the combination MPs with Cd, but not with MPs alone (PS commercial particles). The individuals were exposed to higher concentration (2 mg MP.L-1) than those used for our study. Métais et al. (2023) reported a significant decrease of GST activity, after 21-days exposure, in gills and digestive glands of *S. plana* exposed to low concentration of MPs (0.008 μ g.L⁻¹) compared to the control but not for the highest concentrations (10 and 100 µg.l⁻¹). Therefore, GST activity is probably not induced at low environmental concentrations, and expression of gst appeared only at low MP exposure concentrations, while the cat gene takes over for high MP concentrations.

The PCA realised on the data obtained from the digestive mass analysis, showing that exposure to EMPs was positively correlated to an increase in the activity of CAT and GST, and negatively correlated to the activity of AChE, suggested the clam response to an oxidative stress, the establishment of a detoxication process and a neurotoxic effect. This response was not observed in gills except for the CAT activity. This has been previously reported by Revel et al. (2019), who showed an increase in CAT activity in gills of mussel (Mytilus spp.) at the highest tested concentration of MPs (100 μg.L⁻¹), while there was a significant increase in digestive gland at the lowest and medium concentrations of MPs (0.008 and 10 μg.L⁻¹). A similar result was reported by Métais et al. (2023): after 21 days of exposure, significant higher levels of CAT activity were observed in the gills of S. plana exposed to 100 µg.L⁻¹ of MPs compared to the control ones, but there was no significant change for CAT activity in the digestive glands. This difference may be explained by the differential exposure level between tissues due to particle aggregation in stock suspensions (Revel et al. 2019). Another reason of the difference of the antioxidant enzyme response in gills and digestive glands would be the natural differences in physiology of the different organs. Gill is the first organ exposed to environmental contaminants, while the digestive gland is the major organ for the accumulation of metals and other contaminants (Wirnkor et al. 2019). In our study, CAT activity significantly increased already at lower concentration in digestive mass (at 100 µg.l⁻¹) compared to the gills (at 500 μ g.L⁻¹). Parra et al. (2021) also reported a higher induction of CAT activity

in the digestive gland of *C. fluminea* compared to gills, after an exposure to the mixture MPs and Cd, while there is no difference between these two organs when organisms were exposed only to MPs (PS commercial particles). In the green-lipped mussel *Perna canaliculus*, Chandurvelan et al. (2013) observed an increase of CAT activity in digestive gland but not in gills from organisms exposed to cadmium (200 µg.L⁻¹) for 21 and 28 days. Borković-Mitić et al. (2013) also observed higher CAT activity in the digestive gland compared to the gills, after exposure of the freshwater bivalve *Unio tumidus* to metals. Metals and some other contaminants are considered as additives integrated or adsorbed to the plastics found in the environment. More and more studies focus on the toxicity of additives on bivalves, and some of them highlighted an oxidative stress (Wu et al. 2018; Capolupo et al. 2021). Since the plastics used in this study were directly collected from the field to evaluate the toxicity of environmentally relevant plastic particles, the oxidative stress could therefore be induced by additives like metals. In this context, it would be interesting to characterize additives associated to the EMPs used in this exposure experiment, while the number of scientific studies on the effects of additives on aquatic organisms is still too scarce.

The induction of the MT gene expression in gills at the lowest concentration suggests a detoxication mechanism involvement. This can be induced by the presence of metal or other organic compounds probably integrated or adsorbed as additives on plastics. In both tissues, the overexpression of acp gene indicated an immune system response at low EMP concentration exposures. A similar result in the immune response has been reported for bivalves exposed to MPs (Mkuye et al. 2022). Métais et al. (2023) reported a significant higher level of AcP activity from the seventh day of exposure in S. plana after exposure to the lowest concentration of MPs (0.008 μg .L⁻¹) compared to 10 μg .L⁻¹, corroborating the overexpression of acp found in this study.

Moreover, AChE, that splits acetylcholine into choline and acetate, is essential in transmitting nerve impulses among synapses (Modesto and Martinez, 2010). In gills, neither a change of AChE activity nor of the *ache* gene expression was depicted. However, in digestive mass, a significant inhibition of the AChE activity of clams exposed at 500 μg.L⁻¹ and a significant increase of the *ache* gene expression at 10μg.L⁻¹ have been reported. This may be related to the inflammation of the visceral mass since it has been reported that inflammatory conditions can trigger the up-regulation of *ache* gene expression (Oliveira et al., 2012). Consistent with some previous studies (Guilhermino et al. 2018; Parra et al. 2021; Fu et al. 2022), AChE activity inhibition induced by MPs was observed in the current study. As explained by Fu et al. (2022), a possible reason contributing to the inhibition of AChE is that the enzyme structure was changed through adsorption (Tan et al. 2020). Thus, the MPs could act as AChE inhibitors, that may affect bivalve behaviour, including the feeding ability and the ability to recognize and avoid predators (Pan and Dutta, 1998). Fu et al. (2022) highlighted that disturbance to AChE activity may lead to weakened ability to uptake food from water. These changes were confirmed by a decrease in the

filtration rate in the exposed *Corbicula fluminea*. However, in our study, the filtration efficiency was not disturbed when comparing control and exposed clams. This is in accordance with the results of Revel et al. (2019). The authors did not report a significant difference in the clearance rate between control and exposed mussels. Moreover, the expression of the *cox* gene did not change, neither in gills nor in digestive gland in the exposed clams. This suggests that the respiratory chain was not impacted by an exposure to EMPs at the chosen concentrations.

In addition, MDA levels are an important biomarker of oxidative damage in aquatic organisms, which contain high amounts of lipids with polyunsaturated fatty acid, a substrate for oxidation (Lushchak, 2011). In our study, no significant increase of MDA level was reported in the digestive mass, which is consistent with the studies of Parra et al. (2021) and Guilhermino et al. (2018). Indeed, Parra et al. (2021) did not report significant lipid peroxidation in the digestive gland of Asian clams exposed to 2 mg MP.L⁻ 1 and Guilhermino et al. (2018) did not report significant lipid peroxidation in the digestive gland of Asian clams exposed at both 0.2 and 0.7 mg MP.L⁻¹. These results indicate that lipid peroxidation does not occur in this organ, even at high concentrations of MPs, because it might be compensated by the antioxidant enzymatic activities. However, in our study, a significant decrease of MDA content was reported in gills of exposed clams to 0.008, 10, 100 µg MP.L⁻¹ compared to the control group but not for the highest concentration (500 μg MP.L⁻¹). Ribeiro et al. (2017) also reported a decrease of oxidative damage to lipids in the gills in PS MPs exposed clams (Scrobicularia plana) compared to the control group. The authors explained that this could be linked to antioxidant defences, which consequently limit the attack of reactive oxygen species to membrane lipids (Ribeiro et al. 2017). Parra et al. (2021) showed that exposure to Cd alone, MPs alone and the mixture of both induced significant increase lipid peroxidation levels in gills. Oliveira et al. (2018) also observed a significant oxidative lipid damage in C. fluminea exposed to a mixture of MPs (0.13 mg, L⁻¹ of fluorescent red polymer microspheres of unknown composition between 1 and 5 µm diameter) with mercury, but not in clams exposed to MPs only. This suggests that mercury is responsible for this damage.

Finally, results of the current study showed the interest of using different complementary ecotoxicological tools. Indeed, biomarker activities and energy reserves level changes were significant for the highest concentrations of the EMPs exposure, while changes of gene expressions occurred at the lowest EMP concentrations. This means that the transcriptomic tools targeting expression of genes involved in the main pathways of stress responses would help to predict microplastic effects in bivalves at high biological levels (biochemical and individual) but also at high concentrations of MP exposure.

Effects of EMPs at biochemical level: energy reserves

Exposure to EMPs caused a decrease of the energy reserves in *C. fluminea*. To our knowledge, this is the first study reporting data on energy reserves on *C. fluminea* exposed to MPs. Although no difference was observed in protein levels, a decrease in lipid and glycogen contents was depicted in

clams exposed to the two higher concentrations of MPs (100 and 500 µg.L⁻¹), after 21 days of exposure. A protein breakdown is considered as a last resort, only occurring during prolonged starvation or periods of extreme energy demands (Haider et al. 2018). A decrease in the protein content in MPs-exposed bivalves indicate therefore severe energy deficiency, which is not the case in the current study. A change in energy reserves in bivalves exposed to MPs was supported by other studies. For example, Bour et al. (2018) concluded that larger PE particles (125–500 μm) had more severe effects on energy reserves of Ennucula tenuis and Abra nitida than smaller ones (4–6μm and 20–25μm), possibly due to a longer residence time in the gut that can cause physical damage. Also, Shang et al. (2021) reported a decrease of energy reserves of mussels Mytilus coruscus exposed to 2 μm polystyrene microspheres. MPs have been demonstrated to significantly suppress the energy assimilation efficiency of mussels (Gardon et al. 2018; Pedersen et al. 2020). In our study, both glycogen and lipid reserves undergo depletion at 21 days of exposure at 100 and 500 μg.L⁻¹ indicating an energy cost for *C. fluminea* at high MP concentrations. However, it is possible that these different energy reserves have already decreased before 21 days of exposure. In their study, Shang et al. (2021) demonstrated an early depletion of glycogen (day-7) but also a rapid resynthesis after the end of MP exposure of the mussels reaching the baseline levels after 7 days of recovery. In contrast, depletion of lipids and proteins occurs later during the MP exposure and takes longer to recover after the exposure end. Lipid metabolism is the primary pathway through which energy is supplied in organisms, playing an important role in the response to environmental stress in aquatic invertebrates (Lee et al. 2018). However, to deep knowledge of the biological mechanisms, energy reserves might be analyzed in separate tissues.

Conclusion

This study aimed to evaluate the toxicity of environmental MPs on the freshwater bivalve *Corbicula fluminea* under environmental realistic conditions. Therefore, for this laboratory experiment exposure microplastics were made up from plastic litter collected *in situ* and the exposure concentrations were considered as environmental. This paper is the first that reports ecotoxicological effects on aquatic organisms exposed to EMPs from the Loire, the longest French river. We demonstrated that the effects were dependant on the tested concentrations: biochemical responses have been generally reported at the two highest exposure concentrations while molecular responses were reported at the two lowest concentrations in both tissues. Also, we showed that effects were dependant on the tissues. Finally, from these results, it appears that a transcriptomic approach targeting genes involved in stress response helps evaluating the slight differences in toxicity of the different tested plastic conditions on the Asian clam. Also, it suggests that this approach could be relevant in order to predict effects at higher levels (biochemical and individual) of the biological organization in the concept

- 608 of Adverse Outcome Pathway (AOP). This is particularly important with regard to plastic pollution whose
- 609 effects on humans are difficult to investigate.
